The Primary Election is scheduled for June 28, 2022. Bureau County residents who are registered voters but physically incapacitated and unable to go the polls may vote by a mail-in ballot. Persons may apply for an mail-in ballot by contacting the Bureau County Clerk's office at 700 South Main Street, Room 104, Princeton, IL. 61356, or by calling 815-875-2014.

A resident needs to be registered with a current address in order to vote in the upcoming election. They may complete a voter's registration form at the County Clerk's office.

If a voter needs assistance at the polls, either in marking or reading two election judges (one from each party) may assist the voter.

Any registered voter may vote early by appearing in person at the County Clerk's office from May 19th – June 27th. Our office hours are Monday – Friday, 8:00am-4:00pm. Beginning June 13th early voting will be available at the Princeton Moose Lodge and the Spring Valley City Hall.
